To Apply: Complete our Skip A Payment form and fax it to 248-814-4003 or mail back to the credit union at P.O. Box 99 Lake Orion, MI 48361. If approved, we'll deduct the \$25 fee from your savings account, checking account or you may send a check.

This form must be received no later than the 10th of the month you are skipping.

By participating in Lakes Community Credit Union's Skip-A-Payment program, you request that Lakes Community Credit Union defer your loan payments as indicated. You agree and understand that: 1) FINANCE CHARGES will continue to accrue at the rate provided in your original loan agreement, during and after this time; 2) deferring your payment will result in your having to pay higher total FINANCE CHARGES than if you made your payment as originally scheduled; 3) the payment deferral will extend the terms of your loan(s) and you will have to make extra payment(s) after your loan(s) would otherwise be paid off 4) you will be required to resume your payments the following month; 5) a fee of \$25 per loan will be deducted from a savings or checking account for this service at the time the request is processed. *6) Loans that have incurred a late fee in the preceding six (6) months, have gone into payment modification, had CPI Insurance added or, in the case of auto loans, are not adequately collateralized are not eligible for the Skip-A-Pay option. If you elected GAP or Credit Life or Credit Disability Coverage, the coverage will not be extended beyond the original maturity date. All deferrals are subject to Lakes Community Credit Union approval. Your loan(s) must be current (have no amount past due) to accept this offer. Certain restrictions may apply. Excludes all real estate loans and line of credit loans. 7) You may only skip one loan payment per calendar year.
